ALL BOOTHS MUST BE SAFE AND NOT CONSTITUTE ANY HAZARD. DRAPE ALL BOOTH OR TABLE FRONTS WHERE EXPOSED TO VIEW AND KEEP ALL PACKING MATERIALS OUT OF SIGHT.
2. CRAFTERS/VENDORS ARE RESPONSIBLE FOR THEIR MERCHANDISE IN CASE OF LOSS OR DAMAGE.
3. NO PETS, PROFANITY ITEMS, OR ANYTHING THAT IS NOT APPROPRIATE FOR A FAMILY SETTING.
4. NO NAILS, SCREWS, STAPLES, ETC. MAY BE PUT IN THE WALLS, FLOORS OR CEILINGS.
5. ALL PROCEEDS FROM THE SALES ARE YOURS. COLLECTION, REPORTING AND PAYMENT OF IL STATE TAX IS THE SOLE RESPONSIBILITY OF THE CRAFTER/VENDOR.
6. NO ONE UNDER THE AGE OF 18 CAN OPERATE A BOOTH WITHOUT AN ADULT PRESENT.
